WHEREAS, certain sewer easements were acquired for an earlier development, and

WHEREAS, the present development of the property requires the quitclaiming of the existing sewer easements; and

WHEREAS, the aforementioned sewer easements will no longer serve the public purpose for which they were acquired; and

WHEREAS, the City has no present or prospective public use for the sewer easements, and the City Manager has recommended that the City abandon its interests therein; and

WHEREAS, said easements were acquired at no cost and GAB PARTNERSHIP and KATHAL CORPORATION have paid all City costs in connection with processing the matter of quitclaiming said easements; and


WHEREAS, the processing costs of the abandonment will be the consideration for the sale of the City's rights; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Mayor and the City Clerk are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 261819- /, quitclaiming to GAB PARTNERSHIP and KATHAL CORPORATION, all the City's right title and interest in the sewer easements, as more particularly described in the quitclaim deed.

BE IT FURTHER RESOLVED, that the City Clerk of said City be,
and he is hereby authorized and directed to cause the deed, and a
certified copy of this resolution, attested by him under seal, to
be recorded in the office of the County Recorder.
