

BE IT FURTHER RESOLVED, that funding in an amount not to exceed \$57,000 for the proposed Work Program from any equivalent or greater amount of 1985 CDBG funds which might be allocated for Mid-City commercial revitalization, is hereby authorized and approved.

BE IT FURTHER RESOLVED, that the establishment of a full-time staff position to manage the Oak Park project in conjunction with other Mid-City commercial revitalization efforts, and the expenditure of an amount not to exceed \$32,000 for such purpose from the 1984 Mid-City Commercial Revitalization Project, is hereby authorized and approved.
