Paul G. Zielins	General Services	\$ 975	Mr. Zielins was a Mechanic in the Equipment Division at the time of his suggestion. One year ago he suggested the installation of a Variable Speed Governor on the Detroit Diesel trash trucks. One year's experience has shown a savings of \$6,514.00. This is the remainder of his award.
Robert C. Hauptman	General Services	\$ 830	Mr. Hauptman is a Refrigeration Mechanic in the Buildings Division. One year ago he suggested that the 60-ton refrigeration compressor at the San Ysidro Community Center be replaced with a 30-ton compressor. One year's experience has shown a savings of \$9,855.20 in energy costs. This is the remainder of his award.
William J. Corbett	Attorney	\$ 500	Mr. Corbett is the Supervising Litigation Investigator. He suggested requiring "Engineers of Work" to submit Certification of Responsibility charge statements with engineering maps and plans for subdivision and City projects. Although actual savings cannot be determined, significant savings will occur as a result of a reduction in claims against the City.
