Charles R. Lyons	Water Utilities	\$ 470	Mr. Lyons is an Equipment Technician III in the Metro Wastewater Division. He suggested the installation of 3½ inch vises on the maintenance carts. This is expected to save \$3,120.54 in labor costs. This is a partial award pending a 12-month review.
Vincent DeLeva	General Services	\$ 250	Mr. DeLeva is an Electrician Supervisor in the Communications and Electrical Division. He suggested the installation of strobe type where beacon lights are necessary. This was considered to be a significant operational improvement.
Thomas W. Dush	Fire	\$ 50	Mr. Dush was a Fire Engineer at the time of this suggestion. He suggested the installation of safety hoops on hose rollers. This was considered to be a significant safety improvement.
