Philip A. Scheer	General Services	\$ 50	Mr. Scheer is a Refrigeration Mechanic in the Buildings Division. He suggested the installation of shrouds on air conditioning units with direct sun light on condensor coils. This was considered to be a significant operational improvement.
Ruth E. Klauer	Clerk	\$ 45	Ms. Klauer was a Senior Typist in the Information Retrieval Section at the time of this suggestion. She suggested using the work order number on specification books as the official document number. One year's experience has shown a savings of \$1,203.45 in labor costs. This is the remainder of her award.
