WHEREAS, the Council of The City of San Diego held a public hearing to consider the amendment to the SERRA MESA COMMUNITY PLAN; and

WHEREAS, the Council of The City of San Diego, by majority vote, approved the amendment of the SERRA MESA COMMUNITY PLAN; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That this Council hereby approves the amendment to that plan entitled SERRA MESA COMMUNITY PLAN, by incorporation of the NORTHSIDE SPECIFIC PLAN and addendum thereto, a copy of which is on file in the office of the City Clerk as Document No.
