RESOLUTION OF FEASIBILITY FOR THE IMPROVEMENT OF CITY HEIGHTS BLOCK GRANT STREETS AND ALLEYS CONTRACT NO. 3B.

WHEREAS, the hearings provided for in Resolution of Intention No. R-261483 have been held at the time and place fixed, and all continuances, if any, were duly made and ordered; and

WHEREAS, at said hearings all persons desiring to be heard were fully heard and all oral and written protests and objections, if any, were fully considered and this Council gave all persons present an opportunity to hear and be heard in respect to the proposed improvement; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. Written protests or objection against the proposed improvement has not been made by the owners of more than one-half of the area of the land included within the assessment district or of the area of property to be assessed. A all oral and written protests and objections, except those with respect to Alley Block 5, Bungalow Park Addition, made or filed in the matter are hereby overruled and denied.
- 2. The protests and objections of the property owners in the portion of the district surrounding Alley Block 5, Bungalow Park Addition are hereby granted and the improvements for that area are hereby deleted and removed from City Heights Block Grant

Streets and Alleys Contract No. 3B and are also deleted and removed from the district.

3. The remainder of proposed improvements within the limits mentioned in Resolution of Intention No. R-261483 are hereby determined to be feasible and that the lands to be assessed therefor will be able to carry the burden of such proposed assessment, and that the public convenience and necessity require the proposed improvement, and that the Special Assessment Investigation, Limitation and Majority Protest Act of 1931 shall not apply.
