RESOLUTION NUMBER R- 261873

ADOPTED ON NOV 5 1984

WHEREAS, the United States Navy in the construction of its new Regional Medical Facility is undergrounding certain street safety lighting systems in Balboa Park; and

WHEREAS, there is one street safety light on Pershing Drive which is outside of the scope of work of the Navy's construction program; and

WHEREAS, there are sufficient 8209 funds available to pay for the undergrounding of the overhead utility lines serving the street safety light on Pershing Drive; NOW, THEREFORE,

BE IT RESOLVED, that the City Council of The City of San Diego, hereby authorizes the allocation of \$30,500 of San Diego Gas and Electric Company PUC case 8209 funds for the undergrounding of one street safety light and the service thereto on Pershing Drive East of Zoo Place.

BE IT FURTHER RESOLVED, by the Council of The City of San Diego, that the expenditure in the amount not to exceed \$500 from CIP 37-028, Fund 30245, is hereby authorized, solely and exclusively for the purpose of providing funds for administering the said undergrounding project and related work.
