

RESOLUTION NUMBER R- 261874

ADOPTED ON NOV 5 1984

WHEREAS, the vacation of the City's interest in an unneeded access and water easement affecting Lot 12, Block 5, and a portion of Goldenrod Street vacated, in Sorrento Lands and Townsite, Map Nos. 362 and 483, as more particularly described in the legal description attached hereto as Exhibit "A", has been requested by the affected property owner; and

WHEREAS, the owner wishes to clear title to his land of all unnecessary easements in order to permit better utilization of the property; and

WHEREAS, the herein-described easement has never been used, and is surplus to City needs; and

WHEREAS, this action is exempt from the provisions of the California Environmental Quality Act of 1970 under City guidelines for implementation of said Act, as amended; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


1. That pursuant to Section 8300 et seq. of the Streets and Highways Code the access and water easement, as more particularly described in the legal description attached hereto, is hereby vacated.

2. That the City Clerk of said City be, and he is hereby authorized and directed to cause a certified copy of this

office of the County Recorder.
