ADOPTED ON NOV 5 1984

WHEREAS, Section D, paragraph 1 of the Declaration of Restrictions applicable to South San Diego Industrial Park, Unit 1, City Document No. 764421, authorizes amendments to said Declaration of Restrictions by resolution of the City Council; and


WHEREAS, it has been recommended by City staff that the existing restriction relating to ground-mounted signs which presently prohibits any such signs should be modified to allow such signs subject to the prior approval of the City Manager; NOW, THEREFORE,

BE IT RESOLVED, that the last sentence of Section 12, subsection (b) is hereby amended to read as follows:

"Any proposed ground-mounted identification signs or logos shall be submitted in detail to the Committee for review. The Committee shall have the absolute discretion to approve or disapprove any such ground-mounted identification signs or logos. Approval of any such proposed sign or logo must be obtained from the Committee prior to applying for building permits."
