ADOPTED ON NOV 5 1984

WHEREAS, on August 13, 1984, the Rules Committee reviewed a proposed "Arts Plan for The City of San Diego" drafted by COMBO under the auspices of the State/Local Partnership Program for the Arts; and

WHEREAS, at that time, the Rules Committee concluded that further review including public input and revision of the draft Plan by the City were necessary in order to produce a viable planning guide for the art and cultural affairs of the City; and

WHEREAS, acting upon the recommendation of the Rules Committee, the full Council on August 20, 1984 adopted Resolution No. R-261420 directing the Committee to review, conduct public hearings and make recommendations on the proposed "Arts Plan for The City of San Diego;" and

WHEREAS, the Council directed that the City Manager, Planning Director and Intergovernmental Relations Director provide staff support to the Rules Committee in undertaking the Arts Plan revisions and the Council also authorized the use of consultants to advise the Committee on necessary Plan revisions; and

WHEREAS, a draft work program setting forth the proposed steps to be considered by Council to review/revise the acts Plan was promulgated; and

WHEREAS, said work program is contained in an attachment to Intergovernmental Relations Department (IRD) Report No. 84-59; and


WHEREAS, said IRD Report No. 84-59 and draft Arts Plan Work Program was considered by the Rules Committee on October 22, 1984 and approved by a 4-0 vote; and

WHEREAS, the Rules Committee now forwards the matter to the full Council with a recommendation to approve the Work Program; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to the affirmative recommendation of the Rules Committee, after due deliberation of the matter at the meeting of October 22, 1984, the Arts Plan Work Program set forth in the attachment to IRD Report No. 84-59, be and the same is hereby approved.
