WHEREAS, said abutter's rights of access are no longer needed by the City and should be revested in the property; NOW,


THEREFORE,

1. That the Mayor and the City Clerk are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR-261903-1, quitclaiming to CENTURY PARK LTD. the revestment of those abutter's rights of access in and to Kearny Villa Road adjacent and contiguous to Lot 1, City of San Diego Industrial Park Unit No. 1, Map 3978, as more particularly described in the quitclaim deed.

2. That the City Clerk shall cause the deed, and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
