LEGAL DESCRIPTION

A 15.00-foot strip of land lying within Lot 2 of Rosedale Tract in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 825 filed in the Office of County Recorder of said County January 21, 1897, the Westerly line of said strip being more particularly described as follows:

Beginning at the Northwest corner of Lot 3 of Villa Pacifica Unit No. 1 according to Map thereof No. 7505 filed in the Office of County Recorder of said County December 14, 1972; thence along the Northerly prolongation of the Westerly line of said Lot 3 North $10^{\circ}05'00''$ West (record North $10^{\circ}04'57''$ West) 12.60 feet; thence North $03^{\circ}13'51''$ West, 230.51 feet to the intersection of the Southeasterly line of Lot 1 of Murphy's Mound Unit No. 1, according to Map thereof No. 5909 filed in the Office of County Recorder of said San Diego County on June 30, 1967 and the Easterly line of that portion of said Lot 1 deeded to the State of California by File/Page No. 79-252151 dated June 19, 1979.

The Easterly line of said 15.00-foot strip shall be lengthened or foreshortened so as to begin in the Northerly line of said Lot 3 and terminate in the Southeasterly line of said Lot 1.
