WHEREAS, the issue of the Bullet Train has progressed to the point of legal action by five (5) cities against the project; and

WHEREAS, The City of San Diego has joined as a named plaintiff in said action; and

WHEREAS, the City Council has approved an allocation of \$5,000 to help defray necessary legal expenses as a pro-rata share for and on behalf of The City of San Diego; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$5,000 within the General Fund 100, from the Unallocated Reserve (605) to the Allocated Reserve (901) for the sole and exclusive purpose of defraying legal expenses in the litigation against the Bullet Train.

BE IT FURTHER RESOLVED, that any and all legal expense contributions on behalf of the City in the above-cited litigation, not to exceed \$5,000, be made in a manner and to the appropriate organization as may be determined and approved by the City Attorney.
