BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$17,016 from the General Fund Unallocated Reserve (Fund 100, Organization 60531, Object Account 4947) to Non-Departmental Expense

(PE 60143) for additional lease costs, and \$41,711 to the City Attorney's budget (Department 045) for relocation expenses.

BE IT FURTHER RESOLVED, that the expenditure of \$76,125 from Non-Departmental Expense for the sublease with Gray, Cary, Ames & Frye during Fiscal Year 1985, is hereby authorized and approved.

BE IT FURTHER RESOLVED, that the City Manager and the City Attorney are hereby directed to review the availability of other facilities that might be suitable for relocation of the entire City Attorney's office and to report back to the City Council in one week with alternatives.
