## RECOMMENDATION

The SEDC Board of Directors recommends that the City Council approve the site plan for Gateway Center East as shown in Attachment I.

#### **BACKGROUND**

On October 23, the City Council considered the SEDC proposed site plan for Gateway Center East. The Council voted to delete the road connection to Boundary Street and requested the Corporation to consider the question of retaining the existing comfort station in Dennis Allen Park. On November 7, the Corporation recommended the City Council's approval of the Park and Recreation Board's recommended park plan and land configuration as shown in Attachment I. This plan would allow for the retention of the comfort station if the community determines it is desirable.

Dennis V. Allen Park was developed under the Open Space Grant program of the U. S. Department of Housing and Urban

Development. Recent legislation has removed a previous requirement that HUD approve any changes in the park, allowing changes to be determined by the local jurisdiction. Hence the Corporation is requesting your approval of the proposed site plan as the basis of proceeding with the Gateway Center East tentative map.


