

RESOLUTION NUMBER R- 261949

ADOPTED ON NOV 13 1984

WHEREAS, Rabbi Morton J. Cohn began his studies in 1926 at Hebrew Union College and the University of Cincinnati simultaneously at the age of 15; and

WHEREAS, Rabbi Cohn was ordained in 1934 after training at the Rabbinical Seminary; and

WHEREAS, Rabbi Cohn had previously served in temples in Memphis, Tennessee; and Niagara Falls, New York; and

WHEREAS, during World War II, he served as a chaplain for the United States Navy in New Caledonia and at Pearl Harbor; and

WHEREAS, in 1946, Rabbi Cohn became the spiritual leader of Temple Beth Israel in San Diego; and

WHEREAS, in 1964, Rabbi Cohn founded Temple Emanu-El; and

WHEREAS, in 1978, Rabbi Cohn had bestowed upon him the title of Founding Rabbi of Temple Emanu-El; and

WHEREAS, Rabbi Cohn has served on the Mayor's Committee on Intercultural Unity, the Community Welfare Council, Children's Home Society, Mental Hygiene Association, Legal Aid Society, United Jewish Federation and the County Water Authority; and


WHEREAS, Rabbi Cohn is now celebrating the 50th anniversary of his ordination; NOW, THEREFORE,
