BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$8,000.00 from Capital Outlay Fund Non-Reimburseable Overhead, CIP No. 58-007 ANNUAL ALLOCATION - OVERHEAD & OTHER CITY COSTS FOR FEDERAL GRANTS is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$300,000.00 from Community Development Block Grant Fund 185191, CIP NO. 37-175 BARRIO YOUTH CENTER SWIMMING POOL is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
