BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and directed to execute, for and on behalf of THE CITY OF SAN DIEGO, an amendment to the subdivision agreement for HIGH COUNTRY WEST UNIT NO. 9, on file in the office of the City Clerk as Document No. RR-256804, to provide for the substitution of HOME CAPITAL CORPORATION, a subsidiary of HOME FEDERAL SAVINGS AND LOAN ASSOCIATION, for AVCO COMMUNITY DEVELOPERS, INC., a California corporation, as subdivider.

BE IT FURTHER RESOLVED, that the public improvements to be constructed pursuant to the aforementioned subdivision agreement shall be completed by July 19, 1986, as provided by the amendment to the subdivision agreement, on file in the office of the City Clerk as Document No. RR- 261966 .

BE IT FURTHER RESOLVED, that bond number Bd 30577, issued by Aid Insurance Company (Mutual), in the amount of \$210,678.00 is hereby accepted as the surety for the required improvements in said subdivision, and substituted as Exhibit "C" to the aforesaid agreement and that bond No. YS 843 7185, issued by Industrial Indemnity Company, in the amount of \$210,678.00, is hereby released.
