RESOLUTION NUMBER R- 261975

ADOPTED ON NOV 19 1984

WHEREAS, Section 8330 et seq. of the California Streets and Highways Code provide a procedure for the summary vacation of an excess right-of-way of a street or highway not required for street or highway purposes; and

WHEREAS, the adjacent property owners have requested the vacation of a portion of Walnut Avenue adjacent to Lot 1 and a portion of Lot 2 of Glenwood Terrace, Map 1169, to facilitate development of their properties; and

WHEREAS, that portion of the street to be vacated is not needed for present or prospective public street purposes; and

WHEREAS, those properties adjoining the street to be vacated will continue to have access; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation is not inconsistent with the General Plan or an approved Community Plan; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

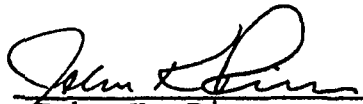
1. That the portion of Walnut Avenue adjacent to Lot 1 and a portion of Lot 2 of Glenwood Terrace, Map 1169, as more particularly shown on Drawing No. 16230-B on file in the office of the City Clerk as Document No. RR- 261975 - 1, which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.

2. That the resolution shall not become effective unless and until a building permit to construct retaining walls within the proposed vacation has been issued. In the event the building permit is not issued by December 1, 1990, this resolution shall become void and be of no further force or effect.

3. That the City Engineer shall advise the City Clerk of the issuance of the aforementioned building permit, and that the City Clerk shall then cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.

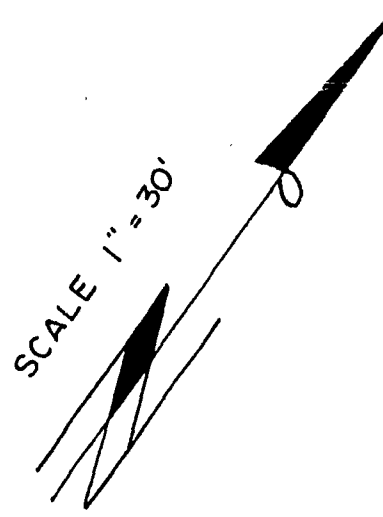
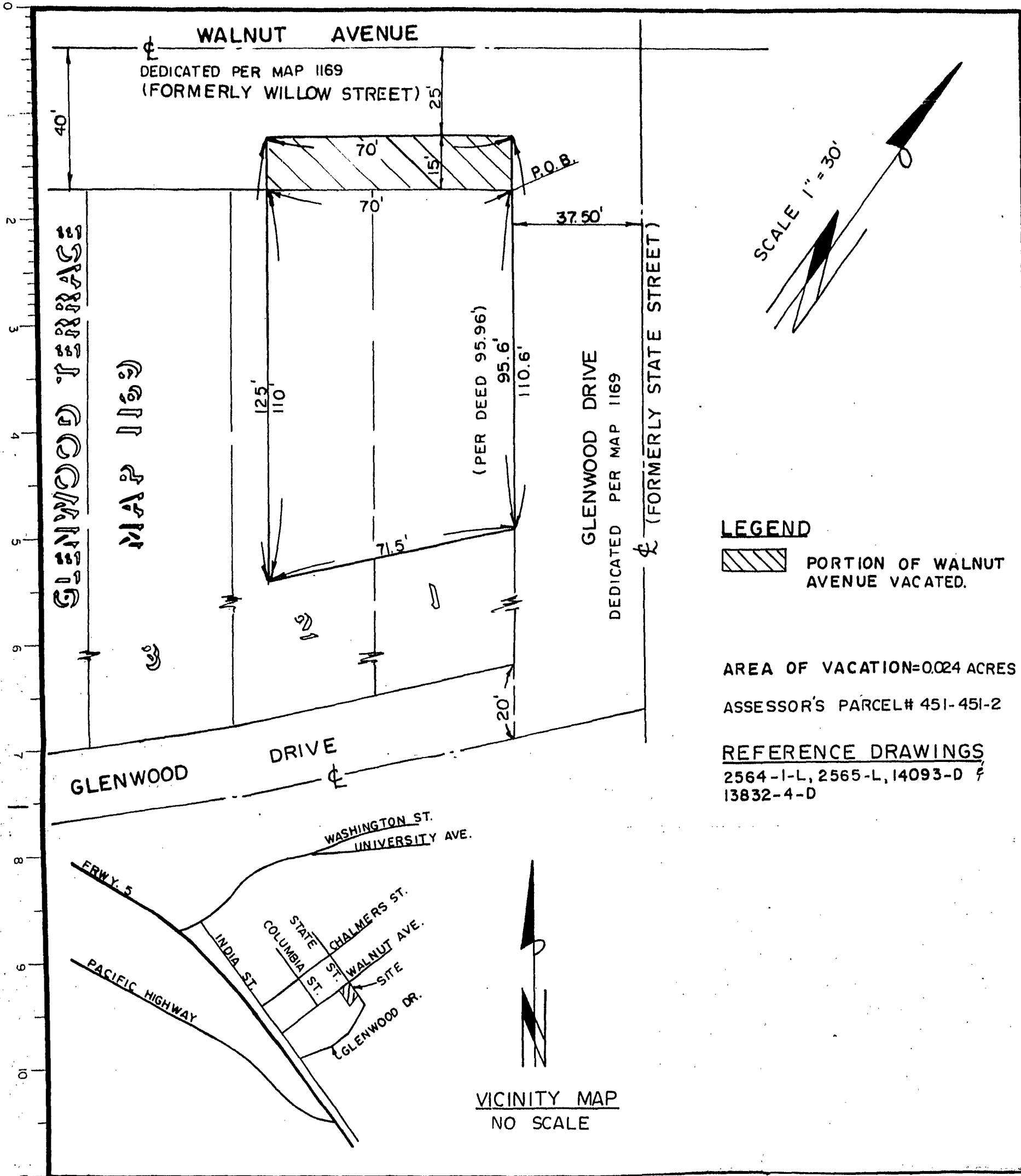
