BE IT RESOLVED, by the Council of The City of San Diego, that the five-year schedule of San Diego Gas and Electric allocations to the City's Utilities Undergrounding program shown on Attachment A of Manager's Report No. 84-417, dated October 10, 1984, is hereby adopted.

BE IT FURTHER RESOLVED, that the Fiscal Year '85 CIP 37-028.0 to reflect a revised undergrounding program as shown on Attachment B of Manager's Report No. 84-417, dated October 10, 1984, is hereby amended.


BE IT FURTHER RESOLVED, that the City Manager is hereby directed to prepare an agreement between the City and San Diego Gas and Electric providing for the systematic acquisition of street lights as undergrounding is accomplished.

BE IT FURTHER RESOLVED, that the City Manager is hereby directed to prepare a revision to Council Policy 600-8 governing the undergrounding program to incorporate the following basic criteria:

- A. No 69 KV lines shall be included in the undergrounding program until all 12 KV lines have been undergrounded.
- B. Undergrounding shall be uniformly accomplished throughout the City .

BE IT FURTHER RESOLVED, that the City Manager is hereby directed to formulate a Council Policy on the use of P.U.C. Case 8209 Funds for underground conversion work on private property.
