
BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to authority conferred by and in accordance with the provisions of Section 85.02 of the San Diego Municipal Code, a TRUCK PARKING PROHIBITION ZONE, be and the same is hereby established on the following street in said City:

Rancho Penasquitos Boulevard, west of I-15 to its terminus; Bernardo Center Drive, west of I-15 to the intersection of Camino Del Norte and West Bernardo Drive northerly of Rancho Bernardo Drive to its terminus.

BE IT FURTHER RESOLVED, that the installation of the necessary signs and markings be and the same is hereby authorized to be made on said street, and the regulations hereinabove imposed shall become effective upon the installation of such signs.
