BE IT FURTHER RESOLVED, that the expenditure in the amount not to exceed \$150,000 from CIP 52-326.0, Del Mar Heights Road Bridge over Route I-5, is hereby authorized, solely and exclusively for the purpose of providing funds for the above program.
