BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an assumption agreement with SANTA FE LAND IMPROVEMENT COMPANY, for the Kenamar Drive and Carroll Road, under the terms and conditions set forth in the Assumption Agreement on file in the office of the City Clerk as Document No. RR-261992-3.
