Florencia V. Santos	Building Inspection	\$1,255	Ms. Santos is a Data Entry Operator in the Customer Services Section. She suggested that an inspection request on a specific permit show up on the computer screen when the permit number is recalled. This is expected to save \$8,361.66 in labor costs. This is a partial award pending a 12-month review.
Robert C. Hauptman Phillip A. Scheer	General Services	\$1,240	Mr. Hauptman and Mr. Scheer are Refrigeration Mechanics in the Buildings Division. One year ago they suggested using City forces to repair the Trane Absorption Chiller. One year's experience has shown a savings of \$6,695. This is the remainder of their award.
Kenneth B. Keller	General Services	\$ 740	Mr. Keller is an Electrician in the Buildings Division. He suggested the installation of a 4 inch PVC over flow drain at Station #23. One year's experience has shown a savings of \$2,462.98 in time, material and equipment. This is the full award.
