<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
George A. Kempland	Park and Recreation	\$ 100	Mr. Kempland was a Grounds Maintenance Manager in the Eastern Division at the time of his suggestion. He suggested requiring the use of battery operational irrigation controllers in new projects. This was considered to be a significant operational improvement.
Philip A. Scheer	General Services	\$ 100	Mr. Scheer is a Refrigeration Mechanic in the Buildings Division. He suggested the installation of minimal sheet ducting on the condenser for vertical discharge. This was considered to be a significant energy savings improvement.
Bartlett C. Brewster Frank W. Day III	Park and Recreation	\$ 50	Mr. Brewster is a Lifeguard and Mr. Day is a Lieutenant Lifeguard both in the Coastal Division. Mr. Brewster suggested a modification of the buoys rescue belt and Mr. Day made an additional improvement of using velcro straps. This was considered to be a significant safety improvement.
