3. That the expenditure of \$21,000.00 from CIP No. 11-219 FEDERAL BOULEVARD STORM DRAIN, to supplement funds previously authorized by Resolution No. R-261460, adopted on September 10, 1984, is hereby authorized solely and exclusively for providing funds for said project and related costs.
