

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for

OCEAN BEACH ATHLETIC AREA PARKING LOT.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$260,802.00 from CIP No. 29-448 OCEAN BEACH ATHLETIC AREA - IMPROVEMENTS (\$180,802.00 from Capital Outlay Fund 30245 and \$80,000.00 from Park Service District Funds) is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
