
ADOPTED ON DEC 3 1984

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and directed to execute, for and on behalf of THE CITY OF SAN DIEGO, an amendment to the subdivision agreement for TENNIS RANCH UNIT NO. 5, on file in the office of the City Clerk as Document No. RR-254026, to provide for the substitution of R. B. McCOMIC, INC. for AVCO COMMUNITY DEVELOPERS, INC., as subdivider.

BE IT FURTHER RESOLVED, that the public improvements to be constructed pursuant to the aforementioned subdivision agreement shall be completed by April 20, 1986, as provided by the amendment to the subdivision agreement, on file in the office of the City Clerk as Document No. RR- 262046.

BE IT FURTHER RESOLVED, that performance bond No. 13 13 80, issued by INSURANCE COMPANY OF THE WEST, in the amount of \$600,570.00 is hereby accepted as the surety for the required improvements in said subdivision, and substituted as Exhibit "C" to the aforesaid agreement and that performance bond No. YS 818 2189, issued by INDUSTRIAL INDEMNITY COMPANY, in the amount of \$434,633.00, is hereby released.
