WHEREAS, Coupons Number Thirty-One (31) due May 1, 1984, each in the face amount of \$118.75 detached from City of San Diego 1966 Sewer Revenue Bonds, Series B, Bond Numbers B405 and B409, each for \$5,000.00 on or about May 10, 1984 were mutilated by obliteration of the serial numbers while in the care, custody, and control of Howard B. Turrentine, and the coupons have not been paid but have been surrendered to the Treasurer of The City of San Diego; and


WHEREAS, a Declaration and Indemnification Agreement on file in the office of the City Clerk as Document No. RR- 262056, has been executed by Howard B. Turrentine as principal, which agreement indemnifies and holds The City of San Diego and Bank of America, NT and SA, harmless from any and all liability for paying or redeeming the coupons; and

WHEREAS, The City of San Diego must authorize approval of the payment before the Paying Agent, Bank of America, makes payment for the mutilated coupons; NOW, THEREFORE;

BE IT RESOLVED, by the Council of The City of San Diego that payment to the bondholder by the Bank of America NT & SA for the above-described mutilated coupons No. 31 detached from Bond Numbers 405 and 409 is hereby authorized.
