BE IT RESOLVED, by the Council of The City of San Diego, that Change Order No. 3, dated September 24, 1984, heretofore filed with the City Clerk of said City as Document No. RR-262068 issued in connection with the contract between The City of San Diego and EDMUND J. VADNAIS, for the construction of Sewer and Water Main Replacements, Group No. 59, said contract having been filed in the office of the City Clerk as Document No. RR-259353, be and the same is hereby approved; and the changes therein set forth, amounting to a net increase in the contract price of \$66,586.01.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$28,670.72 within the Sewer Revenue Fund (41506) from the Unallocated Reserve (70697) to the Sewer Main Construction Program (70492), for the purpose of funding this change order.

BE IT FURTHER RESOLVED, that the additional expenditure of \$28,670.72 from the Sewer Revenue Fund (41506) to supplement Resolutions, R-259353 and R-259984 for the construction of Sewer

and Water Main Replacement Group No. 59, CIP 44-001, is hereby authorized, solely and exclusively for the purpose of providing funds for the above program.
