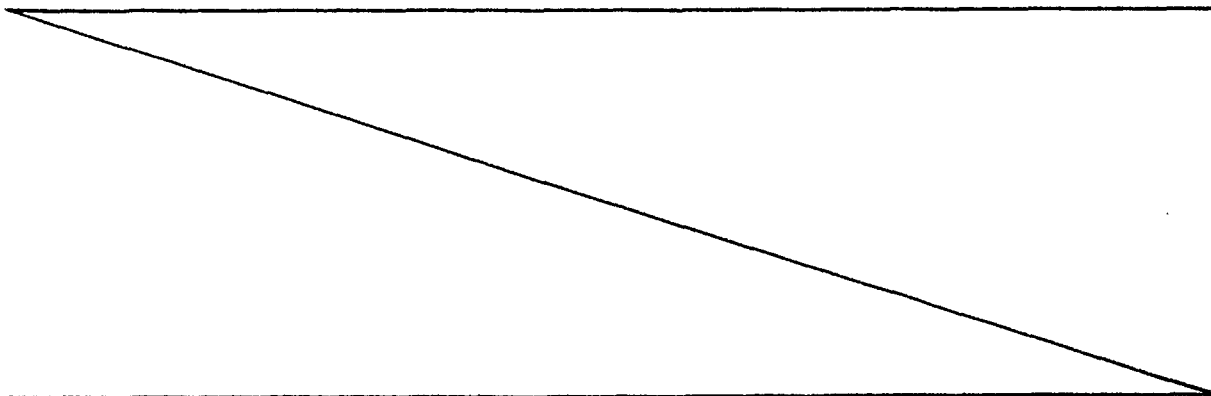
ADOPTED ON DEC 3 1984
