

RESOLUTION NUMBER R-262082

ADOPTED ON DECEMBER 3, 1984

WHEREAS, the City Council has previously allocated \$2,500,000 in 1984 Tenth Year Community Development Block Grant (CDBG) funds to the San Diego Housing Commission for low income housing purposes; and

WHEREAS, a total of \$24,911 is needed to supplement HUD funds in acquiring four low income housing sites; and

WHEREAS, \$24,911 is available from the Housing Commission's approved 1983 Ninth Year CDBG allocation for site acquisition; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with THE SAN DIEGO HOUSING COMMISSION, for use of 1984 Tenth Year Community Development Block Grant (CDBG) funds for purposes of housing rehabilitation, Neighborhood Housing Services, housing site improvements, and program and policy development, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 262082.

2. That the City Manager is hereby authorized and empowered to expend an amount not to exceed \$24,911 from the 1983 Ninth Year CDBG Fund 18519, Dept. 5711, Org. 1103, towards the

acquisition of sites identified as "Grove Avenue" (\$16,832),  
"Sycamore West" (\$415), "Sycamore East" (\$2,536), and "Sycamore  
North" (\$5,128) in order to develop low income housing projects  
previously approved by the Housing Authority of The City of San  
Diego.


