WHEREAS, mediation centers located in Mira Mesa/Scripps Ranch and Golden Hill areas were established to provide a setting to assist citizens in resolving their problems before they escalate into violence by providing an alternative to the criminal justice system; and

WHEREAS, these mediation centers handle disputes involving a wide variety of neighborhood problems; and

WHEREAS, among the issues that might be considered at the centers are: consumer/merchant problems; family disputes; minor criminal acts (trespass, vandalism, shoplifting, etc.); homeowner/property disputes; noise and parking problems; and disputes among minors; and

WHEREAS, the Council of The City of San Diego approved, in concept, the funding of mediation centers during their annual budget hearing process and a total of \$170,000 was reserved for the operation of a mediation program under the aegis of the University of San Diego; and

WHEREAS, the San Diego Law Center, a component of the University of San Diego, submitted a service delivery and expenditure plan for the operation and possible expansion, of the mediation program in San Diego; and

WHEREAS, the funding source for the operation of this program is the City's FY'85 General Fund, and the contract period is January 1, 1985 to December 31, 1985 and the City's sponsoring of this program will enable the project to seek a permanent funding source in either the private or public sector; and

WHEREAS, the City Manager has summarized the background information and discussion thereon in his report to the City Council; and

WHEREAS, it is now appropriate and necessary to execute an agreement with the University of San Diego School of Law for the performance of said community mediation center services; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with UNIVERSITY OF SAN DIEGO SCHOOL OF LAW, to operate community mediation centers in the Mira Mesa/Scripps Ranch and Golden Hill areas in the City of San Diego for a period of twelve months, from January 1, 1985 to December 31, 1985, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR-262083.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$170,000 from the General Fund 100, Program 05580 to Fund 19627 for the sole and exclusive purpose of providing funds for the above authorized agreement.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to expend an amount not to exceed \$170,000 from Fund 19627 to defray costs incurred for the above authorized projects pursuant to the terms and conditions of the executed agreement.
