


RESOLUTION No. R-262096 (R-85-899 )

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bid of OUTBOARD MARINE CORPORATION, Johnson Division, is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of SIX (6) OUTBOARD MOTORS, four each 25 HP outboard motors (OMC-Johnson J25RCO) at a cost of \$1,235.00 each and two each 185 HP outboard motors (OMC-Johnson J185TLCO) at a cost of \$4,721.00 each for a total combined cost of \$14,382.00; terms net 30 days, plus sales tax.
