
WHEREAS, R. Cabral Trucking was the low bidder on the requirements contract authorized by Resolution No. 260658, adopted on May 14, 1984, for furnishing Hauling of Dried Sludge on Fiesta Island (approximately 40,000 cubic yards) for a period of one (1) year beginning July 1, 1984; and

WHEREAS, R. Cabral Trucking is not performing satisfactorily; NOW, THEREFORE, BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That R. Cabral Trucking be declared in default of the contract authorized by Resolution No. 260658.

BE IT FURTHER RESOLVED, that Mark Delise Trucking be awarded the balance of the contract for Hauling of Dried Sludge on Fiesta Island (approximately 40,000 cubic yards) as may be required for the period December 1, 1984 through June 30, 1985, at a cost of \$0.71 per cubic yard for a total estimated cost of \$28,400.00; terms net 30 days, with an option to renew contract for an additional one (1) year period, with price escalation not to exceed 10% of unit price bid.
