
BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for

CONSTRUCTION OF HIGHLAND AND LANDIS COMMUNITY PARK.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$440,051.00 from CIP No. 29-271.2 HIGHLAND AND LANDIS COMMUNITY PARK - DEVELOPMENT, PHASE II (\$279,051.00 from Community Development Block Grant Fund 185191, \$11,000.00 from Park District Fund 15640, and \$150,000.00 from Revenue Sharing Fund 18013) is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
