BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to the authority delegated to the City under California Vehicle Code Section 35700 et seq., commercial vehicles with a rated capacity of over one ton, be and the same are hereby prohibited from operating on the following streets in the City of San Diego:

1. Dairy Mart Road (Monument Road to Servando Avenue).
2. Hollister Street (Monument Road to Tocayo Avenue).
3. 19th Street (Monument Road to Leon Avenue).
4. Tocayo Avenue (Rodear Road to Oro Vista Road).
5. Oro Vista Road (Tocayo Avenue to International Road).

BE IT FURTHER RESOLVED, that the installation of the necessary signs and markings be and the same are hereby authorized to be made on said streets, and the regulations hereinabove imposed shall become effective upon the installation of such signs.
