WHEREAS, there exists in the City of San Diego a need for standard housing units affordable to lower income families; and


WHEREAS, The City of San Diego has recognized this and undertaken programs to help meet this need; and

WHEREAS, federal funds in the amount of \$886,000 have been made available to The City of San Diego to rehabilitate rental properties in order to increase the supply of standard housing units affordable to lower income families; and

WHEREAS, the San Diego Housing Commission is currently implementing a program designed to rehabilitate rental units for this specified purpose; NOW, THEREFORE,

BE IT RESOLVED, that the City Council approves the Program Description and the City Manager is hereby authorized to execute the Rental Rehabilitation Program Application in the amount of \$886,000, a copy of which Application and Description are cumulatively on file in the office of the City Clerk as Document No. RR- 262116 .
