- 5. The adoption of the Carmel Mountain Ranch (formerly Rancho Carmel) Community Plan of August 14, 1984.

- 6. The adoption of the Otay International Center Precise Plan of October 1, 1984.
- 7. Changes to the boundaries resulting from the annexation known as Lower Mission Gorge Reorganization adopted on March 6, 1984.
- 8. Changes to the Phased Development Areas Map to reflect updated community plan area names and the adopted phase shift of the La Jolla Valley area from Future Urbanizing to Planned Urbanizing.
