
WHEREAS, the Council of The City of San Diego has directed the Planning, Engineering and Development and Park and Recreation Departments of The City of San Diego to review means of preserving steep slope areas; and

WHEREAS, said departments have completed a comprehensive study of preservation of open space, regulating hillside development and grading and identifying hillside preservation areas; and

WHEREAS, the Planning Commission of The City of San Diego held public hearings on April 12, May 3 and May 31, 1984 to consider recommendations of the open space preservation study; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that, as part of the open space study, the Planning Department prepare an open space zone, and that the Engineering and Development Department, with assistance from the Planning Department, revise Council Policy 600-4 to include street standards for hillside areas.
