Ronald E. Charlton	Parks and Recreation	\$ 390	Mr. Charlton was a Grounds Maintenance Worker III in the Coastal Division at the time of his suggestion. One year ago he suggested that dumpsters on Sunset Cliffs Boulevard be replaced with trash barrels. One year's experience has shown a savings of \$1,361.72 in contract costs. This is the remainder of his award.
John L. Brewer	Fire	\$ 170	Mr. Brewer was a Fire Captain at the time of his suggestion. One year ago he suggested the conversion and refurbishing of the American La France fire apparatus. One year's experience has shown a savings of \$3,933.00 in replacement costs. This is the remainder of his award.
Lorna M. Murt	Property	\$ 145	Ms. Murt is a Senior Stenographer. She suggested a revision in the distribution of the City Manager Reports. This is expected to save \$484.00 in the first year in material costs.
