
BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to authority conferred by and in accordance with the provisions of Section 85.02 of the San Diego Municipal Code, a TRUCK PARKING PROHIBITED ZONE, be and the same is hereby established on the following streets in said City:

Palm Avenue from I-5 to I-805, Howard Avenue northerly of San Ysidro Boulevard to its terminus, Iris Avenue from 27th Street easterly to Beyer Boulevard, San Ysidro Boulevard from Dairy Mart Road to Howard Lane.

BE IT FURTHER RESOLVED, that the installation of the necessary signs and markings be and the same is hereby authorized to be made on said streets, and the regulations hereinabove imposed shall become effective upon the installation of such signs.
