BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible and reliable bidder for CONSTRUCTION OF SAN DIEGO JACK MURPHY STADIUM EXPANSION - ADDITIONAL SKYBOXES.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$273,000 from the San Diego Jack Murphy Stadium Expansion Fund, CIP 34-1010, is hereby authorized solely and exclusively for providing funds for said project.
