APPROVING MAP OF PACIFIC CORPORATE CENTER UNIT NO. 1

BE IT RESOLVED, by the Council of The City of San Diego that said Council hereby finds that certain map surveyed by Norbert Rudolph Hamelehle, a licensed land surveyor, entitled "PACIFIC CORPORATE CENTER UNIT NO. 1, being a subdivision of Parcel 4 of Parcel Map No. 12137, in the City of San Diego, County of San Diego, State of California, filed in the office of the County Recorder of San Diego County, May 21, 1982 as File No. 82-154336 of Official Records, together with that portion of the southwest quarter of Section 3, Township 15 South, Range 3 West, San Bernardino Meridian, in the City of San Diego, County of San Diego, State of California, according to the United States Government Survey thereof, together with portions of Mira Mesa Boulevard and Carroll Canyon Road as dedicated to public use, together with portions of Carroll Canyon Road, formerly Road Survey No. 466 as closed and vacated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the following: Pacific Heights Boulevard, Cornerstone Court and portions of Mira Mesa Boulevard and Carroll Canyon Road, and said streets and portions of streets are hereby declared to be public streets and portions

of public streets and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Carroll Canyon Road, adjacent and contiguous to Lots 5 and 9; in and to Pacific Heights Boulevard, adjacent and contiguous to Lots 5 through 9, inclusive, and in and to Mira Mesa Boulevard, adjacent and contiguous to Lot 2, all as shown on this map within this subdivision.


BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of drainage and sewer facilities, as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets and portions of public streets are accepted on behalf of the public as heretofore stated, and that those certain abutters' rights of access, together with the easements with the right of ingress and egress for the construction and maintenance of drainage and sewer facilities, all as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to record the street vacation of a portion of Carroll Canyon Road, approved by City Council Resolution R-261628 on October 1, 1984, concurrently with the filing of the map.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
