

RESOLUTION NUMBER R- 262202


ADOPTED ON DEC 17 1984

BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of those drainage, sewer and street easement deeds of SAN DIEGO CEMETERY ASSOCIATION, a California corporation, bearing date of August 31, 1984; and RICHARD A. and MARY M. JONES, bearing date of November 5, 1984, all executed in favor of The City of San Diego, copies of which deeds are on file in the Office of the City Clerk as Documents No. RR- 262202-1, RR- 262202-2, RR- 262202-3 and RR- 262202-4, granting to said City easements for drainage, sewer and public street purposes in a portion of Lot 1 of El Camino Memorial Park, Map 4719, in a portion of the Southwest Quarter of Section 3, and in a portion of the east one-half of the Southeast Quarter of Section 4 of Township 15 South, Range 3 West, San Bernardino Meridian, all as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed for a public street is hereby dedicated as and for a public street, and the same is hereby named CARROLL CANYON ROAD.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
