KNOWLES AND LOUISE ALLEN KNOWLES AS TRUSTEES FOR MICHAEL ALLEN KNOWLES, JEFFREY WILLIAM KNOWLES, NANCY LOUISE KNOWLES AND KEVIN RAYMOND KNOWLES, executed in favor of The City of San Diego, bearing date of October 22, 1984, copies of which deeds are on file in the Office of the City Clerk as Document Nos. RR- 262205 -1 and RR- 262205 -2, granting to said City easements for public street purposes in a portion of Parcel 2 of Parcel Map No. 12137, and portions of Parcels 2 and 3 of Parcel Map No. 12178, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named PACIFIC HEIGHTS BOULEVARD.
