APPROVING PARCEL MAP T.M. 84-0580.

BE IT RESOLVED, that the Council of The City of San Diego hereby finds that certain map surveyed by J. H. Palacios, a registered civil engineer, identified as "Parcel Map T.M. 84-0580, being a division of Lot 4 and portions of Lots 3 and 5 in Block 1 of Bay Shore Addition to New Roseville, Map No. 1152, in the City of San Diego, County of San Diego, State of California, filed in the office of the County Recorder of San Diego County November 16, 1908," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted, and said Council hereby accepts on behalf of the public a portion of Scott Street, and said portion of street is hereby declared to be a portion of a public street and dedicated to the public use, as dedicated and shown on said parcel map and subject to the conditions set forth thereon.


