
ADOPTED ON DEC 17 1984

WHEREAS, the owner of certain property adjacent to Black Mountain Road has requested that the City grant previously relinquished abutter's rights of access to the owner so that his property has access from Black Mountain Road; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Mayor and City Clerk are hereby authorized and empowered to execute a quitclaim deed quitclaiming to GENSTAR DEVELOPMENT, INC., a New York corporation, all the City's right, title and interest in those abutter's rights of access in and to Black Mountain Road, adjacent and contiguous to a portion of Lot 6, Penasquitos Towne Centre, Unit No. 2, Map 11092, as retained by The City of San Diego, and as more particularly described in that quitclaim deed on file in the office of the City Clerk as Document No. RR- 262208-1.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
