BE IT RESOLVED, by the Council of The City of San Diego, that Change Order No. 1, dated September 18, 1984, heretofore filed with the City Clerk of said City as Document No. RR-262210 issued in connection with the contract between The City of San Diego and MONARCH CONSTRUCTION COMPANY, for construction of Sewer and Water Group 62, said contract having been filed in the office of the City Clerk as Document No. RR-259118, be and the same is hereby approved; and the changes therein set forth, amounting to a net increase in the contract price of \$13,640.38.

BE IT FURTHER RESOLVED, that the expenditure of \$13,640.38 from the Sewer Revenue Fund 41506, CIP 44-001, is hereby authorized, solely and exclusively for the purpose of funding this change order.

BE IT FURTHER RESOLVED, that the City Manager is directed to review this contract and the 1983 contract with Monarch Construction Company to determine whether there is any reason that the City should try to recover any of the money paid to the contractor for the performance of the jobs.


